Dear Mr Jakštas,

Following your submission of the amended BMVI Lithuania's programme 2021-2027 via SFC2021 on 6 May 2026, in accordance with Article 24(2) of the Common Provisions Regulation¹ (CPR), the Commission has carried out an assessment of the proposed amendment.

The Commission considers that the proposed amendment is not admissible because it is wrongly identified as a standard amendment (Article 24(1) CPR) and should be classified only as a thematic facility amendment (Article 8 BMVI Regulation). In addition, the following technical corrections should be made:

- The co-financing rates in table 6 of the programme should remain within the maximum percentages allowed per type of action in accordance with Article 12 BMVI Regulation;
- Ensure that the methodological document is updated with the changes to the output and result indicator targets.

We would be grateful if you could submit at your earliest convenience a revised version of the amended programme, which reflects the right typology of amendment.

The [action plan for the implementation of](#) the ISF programme, which includes the planned calls for project implementation plans under all three ISF specific objectives (SO), is published on the website of the Managing Authority [at www.vsfsvp.lt](http://www.vsfsvp.lt). All calls are planned in the way of state project planning.

From the start of the implementation of the programme until the end of the accounting year:

- 11 calls for project implementation plans have been launched;
- 31 grant agreements were signed out of 39 planned;
- EUR 23 295 933.06 of EU funds were contracted (77% of the EU funds planned in the ISF programme);
- EUR 7 845 688.22 (20% of the total allocation of the EU and national contribution planned in the ISF programme) was paid to final beneficiaries;
- 4 projects completed.

In the reference year:

- 4 calls for project implementation plans have been launched for all three SO;
- 6 project implementation plans were invited, 5 project implementation plans were actually received;
- sum of calls EUR 2 155 165,50 excluding the sum of call ISF.9.
- 12 new grant agreements have been signed;
- EUR 7 435 133.24 was contracted (representing 25% of the EU funds planned in the ISF

programme);

- EUR 7 122 021.10 was paid to final beneficiaries (18% of the total allocation - EU and national contribution planned in the ISF programme);

- 31 ongoing projects for all three SO, of which 3 projects were completed, 1 project was completed in the previous reporting year.

To achieve SO1 objectives, 14 out of 17 projects are implemented under the following actions:

1.1. IT systems and networks (10 projects)

1.2. Education and training of relevant law enforcement, judicial and administrative agencies staff and experts (1 project)

1.3. Equipment, vehicles, communication systems and essential security-related infrastructure (3 projects)

EUR 13 990 846.62 of EU funds (80% of SO1) were contracted and EUR 3 286 473.33 of EU and national contribution (14% of SO1) was paid to final beneficiaries.

To achieve SO2 objectives, 9 (two of which are described under specific actions in paragraph 1.5 of this report) out of 11 projects are implemented under the following actions:

2.1. IT systems and networks (1 project).

2.2. *SPECIFIC ACTION* EMPACT actions implementing or facilitating the implementation of the EU Policy Cycle (ISF/2022/SA/2.2.1) – more details in section 1.5 ‘Specific actions’ of this report.

2.3. equipment, vehicles, communication systems and essential security-related infrastructure (5 projects).

2.4. *SPECIFIC ACTION* Council Recommendation on operational law enforcement cooperation – redirecting recommendations to joint actions (ISF/2023/SA/2.1.1) – for more information, see section 1.5 ‘Specific actions’ of this report.

EUR 3 578 937.99 of EU funds (86% of SO2) was contracted and EUR 2 322 248.63 of EU and national contribution (43% of SO2) was paid to final beneficiaries.

To achieve SO3 objectives, 8 out of 11 projects are implemented under the following actions:

3.1. IT systems and objectives (1 project)

3.2. Actions supporting an effective and coordinated crisis response (4 projects)

3.3. education and training of relevant law enforcement, judicial and administrative agencies staff and experts (2 projects)

3.4. Equipment, vehicles, communication systems and essential security-related infrastructure (1 project)

EUR 5 726 148.45 of EU funds (83% of SO3) was contracted and EUR 2 236 966.26 of EU and national contribution (24% of SO3) was paid to final beneficiaries.

Progress in the implementation of the ISF programme is due to the close cooperation between final beneficiaries and managing authority, intermediate body. It is important not only to successfully declare funds, but also to work together to achieve important goals and priorities for Lithuania.

In order to receive additional funding for the mid-term review of the ISF (Article 14 of the ISF Regulation), the managing authority carried out a specific monitoring of ISF projects during the reporting period by informing the BMVI/ISF monitoring committee of the

progress. ISF final beneficiaries were asked to accelerate the activities of ongoing projects, including their procurement and declaration of expenditure to the intermediate body. Meetings were organised with representatives of managing authorities, intermediate body and final beneficiaries to discuss the progress of project implementation, potential risks and investment speed. The objective has been achieved: **the EC allocated an additional EUR 2 649 166.00 to the LT ISF programme following the mid-term review.**

All actions and targets are planned and implemented as foreseen in the ISF programme and the [performance framework of the ISF programme for 2021-2027](#). The milestones planned in the ISF programme and its performance framework were partially achieved during the accounting year, as the planning of indicator values at the stage of preparation of the ISF programme was expected to start project implementation earlier. Nevertheless, all three LT output indicators related to the acquisition of equipment were achieved. The progress of other indicators is slower due to specificities (e.g. indicators related to the opinion of participants in training activities after training) or to the changing situation or needs. Therefore, **there were no significant deviations from the planned indicators during the reporting period.**

Progress towards the achievement of ISF programme indicators is ongoing and we do not currently see a risk of programme indicators not being achieved. Indicator values achieved for the ISF programme during the reporting period:

SO1:

- Number of ICT systems developed/adapted/maintained: 3;
- Number of items of equipment purchased: 175;
- Number of ICT systems that have become interoperable in Member States/EU and decentralised information systems related to security/international databases: 3.
- Number of administrative units that have put in place new or adapted existing mechanisms/procedures/tools/guidelines for the exchange of information with other Member States/Union bodies, offices or agencies/third countries/international organisations: 2.

SO2:

- Number of cross-border operations (of which number of joint investigation teams): 1;
- Number of expert meetings/workshops/study visits/joint exercises: 9;
- Number of items of equipment purchased: 55;
- The value of assets frozen in cross-border operations is estimated at EUR 4.01 million;
- Number of administrative units that have developed/adapted existing cooperation mechanisms/procedures/tools/guidelines with other Member States/Union bodies, offices or agencies/third countries/international organisations: 1;
- Number of staff involved in cross-border operations: 1.

SO3:

- Number of participants in training activities: 31 (of which 31 consider training useful for their work);
- Number of exchange programmes/workshops/study visits: 5;
- Number of items of equipment purchased: 86;
- Number of vehicles purchased: 1.

In order to achieve efficient data exchange between authorities, the Intermediate Body has carried out work to improve the electronic data exchange system.

During the reporting period, **4 Monitoring Committee meetings/written procedures were**

organised to present progress in the implementation of the ISF programme: risks, information on calls for project implementation plans and grant agreements; communication activities. During the reporting period, there were no major issues or challenges affecting the performance of the ISF programme.

The milestones for indicators planned in the ISF programme and its performance framework were partially achieved during the reporting year, as the planning of indicator values at the ISF programme design stage was expected to start project implementation earlier. Nevertheless, the progress of indicator values in the implementation of projects is visible, so there were no significant deviations from the planned indicators during the reporting period. During the reporting period, a change in the values of programme indicators in the performance framework of the ISF programme was made as a result of a change in the ISF programme in the previous reporting year (EC decision of 4 May 2024). During the reporting period, the methodology for drawing up the performance framework remained unchanged.

¹ These are cases where there is a gap between the nominal achievement rate of targets measured by indicators and the actual progress in implementation. For example, insufficient information on outputs and results may be due to problems with the development of the IT system, ongoing actions for which outputs and results have not yet been reported, or problems with data collection leading to slow or incomplete reporting, etc.

Intensified monitoring of ISF projects was also carried out during the reporting period with a view to obtaining additional funding for the mid-term review of the ISF (Article 14 of the ISF Regulation). Following the successful smooth cooperation between the institutions, the acceleration of the implementation of projects and the declaration of expenditure, additional funding for the mid-term review of the ISF was received during the accounting year and preparations for the amendment of the ISF programme started.

During the reporting year, no activities were undertaken or grant agreements were signed for ISF projects with specific measures to mitigate important and sudden changes in the context, as there was no such need.

3. Police Department „European Research Team“

The event featured presentations on "The EU Charter of Fundamental Rights – a value compass" and a presentation on "Instructions for the use of the compass – the implementation of the Charter". They were presented by the experts of the Centre for the Development of Equal Opportunities. 24 participants participated in the event.

1. PERFORMANCE

1.1. Progress made in the implementation of the programme

The [action plan for the implementation of](#) the ISF programme, which includes the planned calls for project implementation plans under all three ISF-specific objectives (SOs), is published on the website of the managing authority [at www.vsfsvp.lt](http://www.vsfsvp.lt). All calls are planned in the way of state project planning.

From the start of the implementation of the programme until the end of the accounting year:

- 11 calls for project implementation plans have been launched;
- 31 grant agreements were signed out of 39 planned;
- EUR 23295933.06 of EU funding was contracted (77% of the EU funds planned in the ISF programme);
- EUR 7 845 688.22 (20% of the total allocation of the EU and national contribution planned in the ISF programme) was paid to final beneficiaries;
- 4 projects completed.

All actions and targets are planned and implemented as foreseen in the ISF programme, the [performance framework of the ISF programme for 2021-2027](#). Progress towards the achievement of the ISF programme indicators is ongoing and there is no risk of programme indicators not being achieved.

In order to receive additional funding for the mid-term review of the ISF (Article 14 of the ISF Regulation), the managing authority carried out a specific monitoring of ISF projects during the reporting period by informing the BMVI/ISF monitoring committee. The objective has been achieved: **the European Commission allocated an additional EUR 2 649 166.00 to the Lithuanian ISF programme following the mid-term review.**

During the reporting period, **4 Monitoring Committee meetings/written procedures were organised** to present progress in the implementation of the ISF programme: risks, information on calls for project implementation plans and project contracts; communication activities. 1.2. Issues affecting the performance of the programme

During the reporting period, there were no major issues or challenges affecting the performance of the ISF programme.

The milestones for indicators planned in the ISF programme and its performance framework were partially achieved during the reporting year, as the planning of indicator values at the ISF programme design stage was expected to start project implementation earlier.

1.3. Specific mitigation measures

During the reporting year, no activities were undertaken or contracts were signed for ISF projects with specific measures to mitigate important and sudden changes in the context, as there was no such need.

1.4. Operational support

No operational support project contracts were signed during the reporting year.

2. COMPLEMENTARITY

For BMVI, AMIF, ESF, ERDF and ISF investments, an informal coordination mechanism is applied. Representatives of the BMVI and the ISF Managing Authority participate in the AMIF Monitoring Committee.

2.2. Multifunctional equipment and ICT systems

During the reporting year, the ISF did not procure equipment and ICT systems that are partly used in the additional area covered by Regulation (EU) 2021/1148 and that pursue the objectives of the Instrument for Financial Support for Border Management and Visa Policy.

- To ensure the successful management of the 2021-2027 BMVI and ISF programmes and to raise awareness of the importance of the EU Charter of Fundamental Rights, the managing authority organised an event entitled 'What the EU Charter of Fundamental Rights Means to Us' for applicants and final beneficiaries of projects funded by the BMVI and ISF programmes and representatives of programme authorities.

- the managing authority carried out communication on the implementation of the ISF programme on the joint website of the Ministry of the Interior and on the website of the managing authority <https://www.vsfsvp.lt>.

- the managing authority, together with the intermediate body, participated in projects with a value of more than EUR 10 000.00 EUR, at the communication events organised by the final beneficiaries, where the results achieved during the implementation of the projects were presented.

- the managing authority oversees the functions delegated to the intermediate body, including ensuring visibility and project information requirements implemented by final beneficiaries.

- The Managing Authority participated in events organised by the National Coordinator, the three Baltic States and the European Commission to discuss communication issues, share national experiences and exchange good practices with representatives of other countries.

5. ENABLING CONDITIONS AND HORIZONTAL PRINCIPLES

5.1. Enabling conditions

The appropriate enabling conditions set out in Annex III to Regulation (EU) 2021/1060 and specified in the ISF programme were fulfilled and applied during the reporting year.
